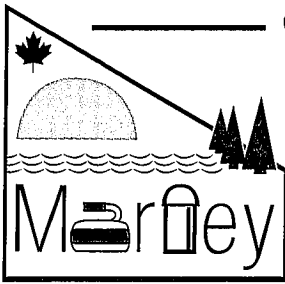

Trusting you will give this matter serious consideration.

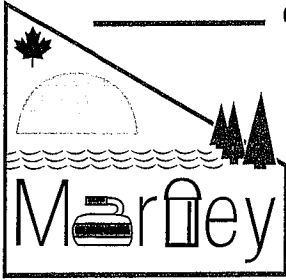

WHEREAS the Government of Ontario has transferred legislative responsibilities for five (5) categories of non-residential and seasonal residential drinking water systems from the Ministry of Environment to the Ministry of Health and Long-Term Care;

AND WHEREAS provincial funding has been provided on a 100% basis for start-up activities, including an initial planning period and for conducting initial site assessments;

AND WHEREAS the majority of small drinking water systems for the Northwestern Health Unit are located in unorganized areas that are remote and difficult to access;

AND WHEREAS in 2012, the funding is expected to be on a cost shared basis representing a financial burden for local municipalities.


